This statement is for the Blackboard virtual learning environment accessed from <http://eat.tees.ac.uk>.

This system consists of the commercial Blackboard platform, third-party plugins and module content. This website is run by Teesside University.

The University will strive to provide accessible lecture content, including the provision of appropriate alternative formats for students who have a Student Support Plan in place.

We want as many people as possible to be able to use this website.

- Within the native Blackboard user interface you will be able to:
- Change colours, contrast levels and fonts.
- Zoom in up to 200% without the text spilling off the screen except where content has been created by a user in such a way to not make this possible (for example within a non-responsive table).
- Navigate the website using just a keyboard.
- Navigate the website using speech recognition software.
- Listen to most of the website using a screen reader.

AbilityNet has advice on making your device easier to use if you have a disability.

Teesside University is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

## **Compliance Status**

This website is fully compliant with the Web Content Accessibility Guidelines version 2.1 AA standard.

## **Non accessible content**

Whilst Blackboard strives to adhere to the accepted guidelines and standards for accessibility and usability, it is not always possible to do so in all areas of the website. We note exceptions to meeting the accessibility standards and guidelines as follows:

- Pre-recorded audio and video content published before 23 September 2020
- Pre-recorded audio and video content is unlikely to be accompanied with a text alternative, captions, audio description or sign language interpretation.

This doesn't meet the following success criterion:

- (non-text content)
- 1.2.1 (audio-only and video-only - prerecorded)
- 1.2.2 (captions – prerecorded)
- 1.2.3 (audio description or media alternative - prerecorded)
- 1.2.5 (audio description - prerecorded)
- 1.2.6 (sign language - prerecorded)
- 1.2.7 (extended audio description - prerecorded)
- 1.2.8 (media alternative - prerecorded)

We do not plan to create a text alternative, captions, audio description or sign language interpretation to prerecorded audio or video content that was published before 23 September 2020 but we do provide transcripts of recordings.

### **Panopto auto-captions**

We use Panopto to create and share recorded learning materials and lectures. Panopto provides captions through automated speech recognition (ASR) a technology that is not 100% accurate. To mitigate the fact that captions will not be 100% accurate, we have provided guidance for staff on how to optimise the quality of captions in their recordings. ## **Disproportionate burden**

### **Legacy content**

Students retain access to their Blackboard modules from previous years for reference. Content provided on Blackboard sites for modules which are no longer being used for active teaching, such as those modules taught during previous academic years, are considered legacy content. It would be considered a disproportionate burden in person hours to bring this legacy content to full compliance. ## **Content that's not within the scope of the accessibility regulations**

### **Live video**

Live video streams do not have captions. This fails WCAG 2.1 success criterion 1.2.4 (captions - live).

We don't plan to create a text alternative, captions, audio description or sign language interpretation to pre-recorded audio or video content that was published before 23 September 2020 but we do provide transcripts of recordings.

## **How we tested this website**

This website undergoes testing against the W3C WAI Web Content Accessibility Guidelines version 2.1 using the automated Siteimprove tool. This tool scans our web pages, and tests against all the criteria in the guidelines.

We also conduct manual testing against known accessibility issues which are not able to be found through automated testing.

This website was last tested on 18/09/2020. The test was carried out by Teesside University.
